## **FIRM LAUNCHES NEW WEBSITE**

The firm has launched its new website. The URL is the same as the old website: [www.begleylawyer.com](http://www.begleylawyer.com) or [www.njelderlaw.com](http://www.njelderlaw.com).

We invite you to visit the website. It is content rich. The home page has a box in the upper right hand corner asking how we can help and lists six areas of law—Medicaid Planning, Medicaid Applications, Estate Planning, Guardianship, Special Needs Trusts, Estate and Trust Administration.

By clicking on the appropriate page the user then has four choices. One is general information, which is a short article dealing with that area of the law, two is frequently asked questions, three is a glossary, and four is a self-diagnostic test all pertaining to that area of the law. The website has a contact information including a form to be sent to the firm inviting us to contact the client.

The website also contains a library again divided by the six areas of law. Each area of law has articles written by firm members which are designed to provide information to our clients. By clicking on the area of law and then searching a list of articles is presented. The user then clicks the name of the article which is linked to the article itself. The home page contains an area for client comments which contains testimonials from previous clients published with their permission.

A page is available for products developed by the firm, including software known as *Asset Protect 1-2-3* for Medicaid calculations, *Essential Estate Planning Document System* which is a complete document assembly system for estate planning containing over 35 forms, letters and checklists all linked, marketing slides for professionals for Medicaid planning and estate planning, books including the following:

Another page contains intake forms. A client can download intake forms and complete them easily to prepare for the initial client meeting. By selecting the "About" button on the home page, the user is directed to pages with a paragraph of information on each of the firm's attorneys.
